Beth Tzedec Sensory Room Waiver Form

In consideration for my use of the Sensory Room and/or the use of the Sensory Room by any child of mine or other person for whom I am responsible (collectively, "**my child**"), I agree as follows:

- I agree that I have reviewed the Beth Tzedec <u>Sensory Room Information Package</u> which includes the Sensory Room Rules and Guidelines of Use and pictures displaying the items available for use in the sensory room.
- ii. I understand that some or all of the equipment in the Sensory Room may not be suitable for individuals with seizure disorders or other conditions. I agree that it is my responsibility to determine whether the use of any of the equipment is appropriate for me and/or my child while inside the Sensory Room during my/our session.
- iii. I agree that it is my responsibility to ensure that equipment in the Sensory Room is undamaged by my use and/or the use of my child during my/our Sensory Room session and that I am responsible if any equipment is damaged during my appointment.
- iv. I agree to forever release and discharge Beth Tzedec Congregation and its officers, staff, volunteers, members, and agents ("Beth Tzedec Persons") from all liability and claims of injury, illness or other damage or injury resulting from the use of any of the equipment in the Sensory Room or from being present in the Sensory Room and I hereby waive any claim which I or my child may have against Beth Tzedec Congregation or Beth Tzedec Persons in connection therewith.

Beth Tzedec Sensory Room Guidelines of Use

- 1. Registration information includes a waiver that must be completed by the parent/ caregiver and the adult accompanying at the time of booking. The waiver will be sent after registration.
- 2. A maximum of 2 participants per session between the ages of 4-18 years MUST be accompanied by a parent / caregiver over the age of 18 years who has completed the waiver as well.
- 3. All adults accompanying children are responsible for room use and must be familiar with the equipment. See Appendix 1 for details.
- 4. All sessions will be 40 minutes. Start and end times will be strictly respected in fairness to other participants.
- 5. A staff member will be present to sign-in participants, facilitate the room's use (not educate), and clean equipment between bookings.
- 6. Entry is available only to those identified on the completed registration form and waiver.
- 7. Participants MUST be accompanied by a parent/caregiver who has signed this waiver.
- 8. To maximize the number of families who can participate, **only 1 booking per family is available** over the Chagim.
- 9. **Special considerations:** Please review the Sensory Room Pop-Up equipment carefully, as some pieces may not be suitable for children/accompanying adults with seizure disorders or other conditions.

Beth Tzedec Sensory Room Rules

- 1. The Sensory Room is **fragrance-free** to protect users with serious allergies and those who may be challenged by smells. All participants must use the fragrance-free hand sanitizer provided before entering the room.
- 2. All participants must check in with staff at the desk outside the room. Please arrive no more than 5 to 10 minutes early to avoid congestion and noise in the hallway.
- 3. **Timeliness:** A 10-minute grace period will be given after which the booking is void. Your 40-minute session includes any transition time your child/children may need to wrap up their experience and leave the Sensory Room so it can be cleaned for the next user(s).
- 4. Shoes or bare feet are not permitted in the room for sanitary reasons and to protect the equipment. Please bring your own clean foot coverings (e.g., socks).
- 5. Please do not allow children to mouth or chew any of the equipment.
